£960 to fund the organization of an interdisciplinary symposium titled "Scotland's NHS? A Workshop on Healthcare Accessibility." Hosted by the University of St Andrews's School of Divinity, this workshop scrutinizes what it means for healthcare resources to be accessible to Scots on the NHS. For example, if someone has a provider nearby but that provider is dismissive of said person's symptoms do they count as having access to care? Questions like these are addressed by participants hailing from a range of fields (e.g., medicine, theology, sociology, philosophy, and so forth) and include both junior scholars and established researchers. Participation is limited to twenty people, including six giving papers, in order to stimulate in-depth discussions and encourage further dialogue after the workshop's conclusion.
